

Information for Self-Authorization Form FOR VEHICLE EXHIBITIONS & NON-SELLING EVENTS WHERE SALES BY ALL PARTICIPANTS ARE PROHIBITED

This form is for NON-SELLING Exhibitions of Motor Vehicles

- SELF-AUTHORIZATION IS NOT APPROVED for licensees participating in events at another dealer's licensed location with the same motor vehicle type product.
- SELF-AUTHORIZATION IS NOT APPROVED at businesses that have member purchasing or member buyer programs unless approved by the Motor Vehicles Division.
- **SELF-AUTHORIZATION MAY BE APPROVED** for a total of 6 consecutive months. Applicants must then re-apply.
- SELF-AUTHORIZATION IS APPROVED at financial institutions.

WHEN SELF-AUTHORIZING EVENTS AT FINANCIAL INSTITUTIONS - APPLICANTS:

- MUST HAVE vehicles marked with clearly stated signage indicating the vehicles are not for sale at the event,
- 2. **MUST NOT** display pricing information in conjunction with the vehicles (EXCEPTION: Monroney stickers must remain as required by Federal law), and
- 3. MUST NOT make Sales or Offers to Sell.

Any activity designed to promote, solicit, induce, influence or encourage a consumer to buy, whether it be advertising or other marketing activity, is considered an "Offer to Sell". An "offer to sell" can be the simple writing of a price on the back of a business card and passing the card to a consumer, a banner across the top of a dealership, or a verbal communication of a suggested price to a consumer. Any indication that vehicles may be for sale is a violation, and could subject you to the possibility of investigation and formal complaint action.

In these events all dealers representing the same line in the county of the approved city and any contiguous counties have equal right to participate. Contact your promoter, motor vehicle association, or the Motor Vehicle Division to determine if the event qualifies for the metropolitan exception.)

I certify under penalty of perjury that statements made above and attachments hereto are true and correct. I acknowledge that this is a NON-SELLING EVENT where sales or offers for sale are prohibited and will not take place. I understand and acknowledge that if a complaint is filed with the Texas Department of Motor Vehicles alleging non-compliance with any statement herein, upon hearing and proof of the truth of such allegations, the applicant or licensee named herein is the responsible party and will be subject to a civil penalty up to \$10,000.00 per day, per violation.
