

## BACKGROUND

The State Fair of Texas® is one of the largest annual events in Texas and is a Dallas tradition. More than three million visitors come through the gates of the State Fair each year for food, fun and to visit Big Tex®, the Fair's 55-foot tall icon. The State Fair of Texas is a 501(c)(3) organization whose mission is to celebrate all things Texan by promoting agriculture, education and community involvement. Through its activities, the State Fair is able to provide scholarships to high school seniors from 4-H and FFA chapters across Texas and Fair Park area high schools. Since 1990, the State Fair of Texas has awarded more than \$20 million to Texas youth and has graduated more than 500 students through the scholarship program.

## PURPOSE

To develop the State Fair's fundraising raffle in support of the Youth Livestock Auction & Scholarship Program. The State Fair Raffle committee will sell \$1 raffle tickets for multiple high value items (vehicles, equipment, trips, packages, etc.). Tickets will be sold through pre-sales across the community and daily during the State Fair of Texas.
