



## 100 Days to the Fair – Sweepstakes Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up by texting "BigTex" to 877-7-BIG-TEX (877-724-4839) and who are 18 years of age or older as of the date of entry. The Campaign is only open to legal residents of **United States** and is void where prohibited by law. Employees of State Fair of Texas, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

3. Campaign Period: Entries will be accepted online starting on June 18, 2019 at 9:00 a.m. CST and ending June 28, 2019, 11:59 PM CST. All online entries must be received by June 28, 2019, 11:59 PM CST.

4. How to Enter: The Campaign must be entered texting "BigTex" to 877-7-BIG-TEX (877-724-4839). Message and data rates apply. Message frequency varies. For terms & conditions + privacy policy, go to <https://pocketstop.com/recipienttou>. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of State Fair of Texas. Optional verbiage to include: You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use

Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by State Fair of Texas. Terms & Conditions: State Fair of Texas reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond State Fair of Texas's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, State Fair of Texas may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by State Fair of Texas. State Fair of Texas reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. State Fair of Texas has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
